How to Participate to Plan?

❑ **Currency Transfer Receipt**

\$ 500,000 shall be transferred to foreign exchange account of the participant candidate and bank receipt be taken.

❑ **Currency Sales Receipt**

500.000\$ is converted into Turkish Liras through the Central Bank and bank receipt be taken. Receipt should have the identification number and signature of the branch personnel and passport number and signature of participant.

In the statement of the receipt; "Citizenship acquisition through the Private Pension System" should be written.

❑ **Citizenship Individual Pension Plan proposal form shall be signed by the participant and the Individual Pension intermediary**

Proposal issued with a minimum regular contribution of 100 TL and initial contribution (Turkish liras for \$500,000 in foreign exchange sales receipt).

How to Participate to Plan?

- The Acknowledgement and Letter of Commitment is signed by the participant.**
- Receipt of Initial Contribution Payment**
